Application for Admission

1. **Deadline is April 1.**

2. Fill out name, birthdate, and other contact information.
3. Fill out high school and college information
4. Select up to two programs that you would like to apply for mark 1st and 2nd choice. If one program is full, you may be considered for admission into the 2nd choice program. If you are only interested in one program, only mark 1st choice.

Application packet materials should be directed towards admission into the GBC CTE programs.

5. Letters of recommendation should be addressed to Bret Murphy, Dean of Applied Sciences, Great Basin College, 1500 College Parkway, Elko, NV 89801. **Letters should be directed towards admission into the GBC CTE programs.** Letters of recommendation may be attached to the application; they do not need to be sent separately.
6. Resume should include all work history. You may also include additional schooling and/or specific classes, school events and teams, personal awards and accomplishments.
7. Your letter of intent is a personal statement about why you should be considered for admission into the GBC CTE programs.
8. High school transcripts, GED scores, military training records and/or higher education records can be sent to Chris Marshall, Great Basin College, 1500 College Parkway, Elko, Nevada 89801. Transcripts/records do not need to be official.
9. Placement testing for Math and English **MUST** be completed by the April 1 deadline. ACT or SAT scores are acceptable. GBC offers the Accuplacer placement tests, free of charge at all campuses/centers. Attach a copy of your scores to this application.
10. You **MUST** complete the GBC **general** application for admission **online** at www.gbcnv.edu/admissions. You must declare a program of study. The Certificate of Achievement (CT) or Associate of Applied Science (AAS) in one of the CTE Programs (Diesel, Welding, Millwright, Electrical, or Instrumentation).

If you would like to apply for the MTC Scholarship, fill out pages 3-5. The scholarship application is optional, not required for admission into the GBC CTE programs.

Applicants are encouraged to submit a portfolio of work.
